A review is substantially less in scope than an audit conducted in accordance with SAs specified under section 143(10) of the Act and consequently does not enable us to obtained assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

Other Matters:

1. During Financial Year, Company was converted from closely held to Public Limited Company on 18.08.2023 and had completed its Initial Public Offering ("IPO") of 26,88,000/- new equity share of face value of Rs.10/- each at premium of Rs.60/- per equity share aggregating to Rs.18/1.00/- and offer for sale number of equity shares 17,76,000 of face value of Rs.10/- each at premium of Rs.60/. Expenses related to IPO Rs.1,36,27,552/- was debited against securities premium Account as per Section 52 of Companies Act,2013. Pursuant to the IPO, the AHLEDARAN ages of company have to get listed on the SME platform of BSE on 27th December,

2023. The Company has utilised the money raised by way of Initial Public offer during the year

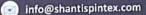

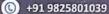
